## Water User's Agreement

The undersigned, being the owner or occupier of land located within the above Public Water Supply District, hereby makes application to said District for \_\_\_\_water service connection(s), and if water service is made available by said District, agrees to the following conditions:

1. To become a water user of the District, I hereby tender a sum of \$ \_\_\_\_\_ for water service connection(s). Of this amount, \$ \_\_\_\_\_ is the service/connection fee which is not refundable after a water connection is made, and \$ 50 is a deposit which is refundable upon disconnection and after all user charges have been satisfied.
2. **Pay a minimum monthly meter charge for the water service connection from time service is made available by the District, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water charge an rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein.**
3. The Rules and Regulations of the District provide that water users **shall pay** their water bills by the 15th of each month and remit to the District per rate schedule in effect. Bills not paid by the 15<sup>th</sup> of the month require 15% penalty added. Bills not paid by 10:00 AM last business day of the month will be charged \$50 Collection Fee. If meter disconnected for non-pay, all moneys past due and current must be paid before service can be restored.
4. If customer damages water meter, they are responsible for repairs. \$60 minimum **plus** cost of parts if needed.
5. The water service supplied by the District shall be for the sole use of the undersigned; the undersigned agrees that he will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will he share, resell, or sub-meter to any other consumer. Each metered service shall supply water to only one residence or business establishment located on and within District.
6. If after water service is made available the same is discontinued or disconnected for any purpose, pursuant to the By-laws and the rules and Regulations of the District, reconnection shall be upon the conditions set out by the By-laws and the Rules and Regulations of the District.
7. The undersigned agrees that he will make no physical connection between any private water system and the water system of the District. Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of service.
8. The laws of the State of Missouri, the By-laws of the District, and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made a part of this agreement as though fully set out herein.
9. The undersigned agrees that he will grant a water line easement to the District for the transmission of water over, under and across any interest he may have in real property bounding the roads along which the initial water transmission lines of the District are planned in consideration for the District accepting this application.
10. The Undersigned certifies that construction materials used in new construction or expansion modification and improvement of customer's existing water system are **lead free**.
11. The location or description of the property to be served by the water service connection is (Set forth either the legal description of the property or the address and location.
